MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) summarizes agreement between **Banda University of Agriculture & Technology, Banda** and **ICAR-Central Agroforestry Research Institute, Gwalior Road, Jhansi - 284 003 (UP) India**, to cooperatively promote research in the post graduate studies for the students of University in pursuance to the Indian Council of Agriculture Research, New Delhi guidelines (ICAR communication F. No. 2-8/2012/HRD dated 11/12/2012) to develop mutual research and training collaboration between State Agricultural Universities, State Veterinary, Dairy and Fisheries. The scope of this MOU will be Master's, Doctoral, research and training programme.

In This MOU, hereinafter "**University**" refers to **Banda University of Agriculture & Technology, Banda (BUAT)**; "**Institute**" refers to **ICAR-Central Agroforestry Research Institute (CARI), Gwalior Road, Jhansi – 284 003 (UP) India**.

Objectives:

1. To use scientific manpower and infrastructure available at both the organizations more efficiently and effectively to conduct quality research in Agroforestry.
2. To extend research facilities of both the organization to the post graduate students and teachers/Scientists of the BUAT and ICAR-CARI for Mutual Benefits in Research and training; national building as a whole.
3. To develop a fodder demonstration farm at BUAT for training of farmers and students

Faculty status:

1. Scientists of the Institute will be recognized as Faculty Members of the University for Research in MSc and PhD programmes in the University, as per the guidelines of the University.

Admission and fee:

1. Admission of the Students and award of the degree for different course programmes will be the responsibility of the University as per their rules and regulations.
2. Allotment of the students will be as per the academic rules of the University.
3. Allotment of students to the Institute and University will be done by a Joint Committee, consisting of minimum two members from both the organizations, nominated by Vice Chancellor, University and Director, Institute.

4. The Faculty of the University and The Institute will be included as members of the Research Advisory Committee of the students.
5. Students allotted for conducting the research work have not to pay any fees for carrying out research work at the Institute.
6. Students will be required to conduct research work within the mandate existing ongoing research project(s) and facilities of the Institute.
7. Synopsis seminar/credit seminar may be organized either at University or Institute as per the convenience of faculty/requirement of the Course.
8. Students of the University will be provided bus and hostel facilities on the basis of availability as per the rules and regulations of the Institute.
9. Library facilities will be extended by both the organizations for consultation to the students and scientists.
10. Students are required to submit one copy of thesis/dissertation to the library of Institute.

Publications and Intellectual Property Rights:

1. In research publication, authorship will be given on mutual understanding among research group.
2. Any IPR issue emanated from joint research conducted under this MOU will be the joint property of the University and Institute. IPR issue will be patented as "Joint Patent".
3. Benefits emanated from commercialization of developed technology under this MOU will be shared between University and Institute. Since both the organization belong to NARS system, the ratio of sharing benefits will be as per the Johl Committee.

General:


1. The University will have the right to accept and to implement/modify the Syllabus/new curriculum as per the University rules/regulations.
2. Each organization shall be at liberty to terminate this MOU with a written notice of a period of three months to the other organization without legal redress.
3. Any dispute under this MOU between University and Institute will be settled in Banda Jurisdiction.
4. Vice Chancellor of the University and Director of the Institute will be signatory to this MOU.

This MOU prepared in two identical copies; each organization will hold one original copy signed.


