2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. 6. ### **Additional Terms and Conditions (ATC):**

1. The rates should be quoted only for AC and Non-AC, Diesel vehicles.
2. **The bidder agency must have atleast 2 years of minimum experience in providing fire vehicle services to ICAR Institutes / Central Government establishment in Jhans and proof documents must be attached in GeM.**
3. Validity: The service contract will be valid for Three Years with the successful bidder/ firm and may be further extendable on mutual consent as per same rate, terms and conditions. However, no hike in the rate will be permissible during this period. The prospective bidder may quote the rate accordingly taking into consideration of this aspect.

34. The vehicle shall be properly/comprehensively insured and should carry necessary fitness certificate from concerned authority including pollution certificate.

35. The firm/agency shall bear all costs on account of fuel, oil, spares, comprehensive insurance, repair and maintenance etc. of the vehicle. The salary/wage and other costs of drivers (liveries, EPF, ESI, other liabilities as per labour/vehicle Act) shall also be borne by the firm/agency only. This whole responsibility will lie with the concerned firm/agency.
  36. The persons/drivers so provided/detailed by the agency/firm for this work under this rate contract will not be considered/treated as employee of the Institute/Council and there will be no employer-employee relationship between the Institute and the person so engaged by the firm/agency for the service/contract work of this tender.
  37. The service provider firm will discharge all his legal obligations in respect of the drivers/workers to be employed/ deployed by him for the execution of this service contract in respect of their wages and service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time. The contractor shall indemnify and keep indemnified that Institute for any claims, loss or damages that may be caused to it on account of any failure to comply with the obligations under various laws. In case of any dispute arises, the decision of the Director of this Institute shall be final and binding on the contractor.
  38. The agency should abide by rules laid down by any authority relevant to the deployment of vehicles.
  39. In case of any breakdown of vehicle on duty, the firm shall make arrangement for providing another vehicle immediately. In such a case, mileage from garage to the point of breakdown would not be paid.
  40. The institute shall not be responsible for any challan, loss, damage or any accident of the vehicle or to any other vehicles or the driver or to any other third party. The loss or damage or legal expenses on the account shall be borne by the firm/agency.
  41. Vehicle shall be made available on all days including Saturdays, Sundays, Holidays & late night also as and when required. The seats and vehicle must be properly cleaned/ towed every day.
  42. **The firm should have authorized office/working premises in Jhansi.** The service provider should be available on his own direct telephone (office as well as residence/Mobile) round the clock.

47. **Fall Clause:** If the firm reduces its price or even offers rate for vehicles mentioned in this bid/tender following conditions similar to those of this bid/tender, at a price lower than the rate offered to this institute, to any person or organization during the contract period or extension period, if any, the rate offered under this contract will be automatically reduced to that rate and the contract order will be amended accordingly.
